DIRECT CREMATION PACKAGE PLAN REQUESTED BY MOST FAMILIES \$1,692.00

Our charge for a direct cremation (without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains within San Diego County, shelter of remains, transportation to crematory, a state-mandated combustible cremation container*, securing necessary authorizations, required Disposition Permit, mandatory DCA fee, and the choice to have cremated remains scattered at sea by Neptune Society, (or) returned to next of kin in a durable plastic urn, (or) delivered to a local cemetery.

*We only offer one type of Cremation Container (Item#CC2-304 Double-walled Cardboard), we DO NOT offer any alternatives

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF & OVERHEAD \$1,200.00

Includes conducting the arrangements conference, planning the funeral, sheltering the remains, securing necessary permits, and coordinating the cemetery or crematory arrangements. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

TRANSFER OF REMAINS TO NEPTUNE SOCIETY (add \$5.00 per mile in excess of 60 miles, one way) \$472.00

EMBALMING OF BODY* \$600.00

Embalming is the addition to, application of, or replacement of body fluids by chemical preservatives for the temporary preservation of the body. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation or Immediate Burial.

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME \$1,100.00

Includes basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains within SD County, shelter of remains, embalming, and transport to San Diego International Airport in utility vehicle (casket not included).

IDENTIFICATION (ID) VIEWING (2 person maximum) \$200.00

Use of facilities for a 15-minute, informal viewing without embalming or cosmetic improvements. Subject to Director approval.

IMMEDIATE BURIAL (**Cost of Casket NOT included) \$1,800.00

Our charge for an unwitnessed, immediate burial (without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal and shelter of remains, transportation to local cemetery, securing necessary authorizations, required Burial Permit and mandatory DCA fee.
